Restrictions: All wall mounted work must be wired and ready to hang, with back wire attached, gallery wrapped and finished. All work must be backtagged with Artist's name, retail price and title of the work. No special installation requirements and no ceiling mounted works. Finished Size of art to be 12"x12" only. We reserve the right to refuse accepted work that arrives damaged, in of poor quality, or is too fragile to be exhibited.

Submission of Work: You may submit your cash exhibition fee in person at either gallery or by using Visa, MasterCard or by Check. Check must be made out to "Art Affair Gallery" or to "James Harper Fine Arts." You may also send your exhibition fee via PayPal by submitting the payment to SUBMIT@artaffairgallery.com, and indicating your receipt number on your entry form. You may submit up to 2 works per entrance fee for hanging. This is an OPEN exhibition. We are not jurying the pieces by jpegs but during the opening reception while on display.

Delivery of Works: Please complete the exhibition form and email it to SUBMIT@artaffairgallery.com and advise us of how many paintings you will be delivering and/or shipping to the gallery. Attaching jpegs is a plus as we will post them online at www.artaffairgallery.com and on www.jhfinearts.com as well as on both galleries Face Book pages.

Payment and exhibition form (including number of works submitted) are due no later than Oct 31st as space is limited and will fill quickly.

Delivery and Return of Works: Artists are responsible for their shipping costs to and from the show. Work must be shipped in a reusable carton/box or packing crate and have pre-paid return shipping label enclosed. **No Styrofoam peanuts!** If hand delivering, works may be picked up, at either James Harper Fine Arts or at Art Affair Gallery when your artwork has finished its exhibition tour. All artwork left at the gallery or without pre-paid shipping label included will become the property of the gallery to dispose as we see fit within 10 days after the close of the exhibition.
